#### **OLD BUSINESS:**

The Association of Florida of Conservation Districts 10<sup>th</sup> Annual Meeting was held on Friday August 1 thru Sunday August 3<sup>rd</sup> in Ocala. Stoddard and Johnson attended and gave a brief report of some of the items discussed during the meeting. Farm Bill programs discussed. Chapter 582 of the Florida Statutes was discussed.
